Traveling by Air? Leave Your Firearms at Home

More people tried to bring firearms onto airplanes last year than ever before, and San Diego was part of that trend.

The U.S. Transportation Security Administration knew it had a problem on its hands as early as October, when the number of guns confiscated at airport security checkpoints had already surpassed the previous all-time high and was continuing to climb.

At San Diego International Airport, 13 individuals were referred to our Office after being caught trying to bring guns onto planes in 2021, nearly as many as the previous three years combined.

This trend is concerning. People expect air travel to be safe, and are alarmed by the increasing number of flights being locked down or diverted because of mask protesters and inebriated passengers. We rely more than ever on the TSA to keep planes weapon-free, but the gun industry works faster, creating new guns and gun parts that are undetectable and untraceable.

When airport police confiscate weapons, the cases are often referred to my office. We can file misdemeanor charges ranging from introducing a weapon into a secure area to carrying a loaded firearm in a public place.

In San Diego, the typical traveler caught by the TSA is a male who has a loaded handgun in his carry-on bag or backpack and no criminal record. About one-quarter of them are current or former law enforcement or military.

Almost always, when caught, the gun owner will say they were in a hurry to get to the airport and forgot the gun was in their bag. Others claim they put the gun in their bag to keep it away from their children, untrustworthy roommates, or even thieving family members.

They are usually cooperative and often upset or frightened about how the arrest will affect their careers and futures. Among those stopped in San Diego were a pastor, lifeguard, real estate agent, plastic surgeon, firearm company employee, and at least two who said they needed to carry a gun because they frequently traveled with large amounts of cash.

The penalties generally include forfeiture of the weapon and fines of up to \$1,000. The courts often order defendants to take firearms safety courses, perform community service, and submit to a Fourth Amendment waiver for a set period of time, which means their persons and property are subject to search if law enforcement believes they are committing new crimes. The defendant may receive court-ordered diversion which keeps them out of jail as long as they remain law abiding and possess no weapons for a set period, usually six months to a year.

In addition, the TSA may levy hefty fines for these violations: bringing a loaded firearm through airport security can cost as much as \$13,910; bringing an unloaded gun on a plane will result in a fine up to \$2,475.

Remember: Travelers are *never* permitted to bring ammunition and loaded or unloaded firearms onboard commercial aircraft in the United States. Unloaded firearms and ammunition may be transported in checked luggage if properly stored in a hard-sided locked case and declared to airline personnel upon check-in. Different states, local governments, and airlines may have additional restrictions. It is up to the traveler to know and abide by them.

Prosecutors in my office evaluate each case on its facts and file charges only when the elements of a crime are present. Sometimes an individual has a reasonable explanation that shows a good-faith attempt to follow the law. Others are not interested in complying with the law: three of the 24 individuals charged by our Office in the past four years failed to appear in court and now have warrants out for their arrest.

Restrictions on firearms during air travel exist to keep all of us safe from the threat of potential gun violence, including accidental shootings, in crowded airports and in our skies. Ignorance of the law, being forgetful, or being in a hurry, is no excuse.

So, regardless of your reason for carrying a gun to the airport, think again. You can save yourself a lot of time, trouble, and costly legal consequences by making sure you comply with laws that keep travelers safe.

What's Happening to Housing?

California Senate Bill 9 (SB 9) effective January 1, 2022 and the City of San Diego's recent changes to the land use code will greatly impact the housing in established neighborhoods. In Serra Mesa there are numerous owners who have or are in the process of making additions to their homes.

The following information focuses only on regulations pertaining to properties zoned for single dwelling units outside of the Coastal Overlay Zone and is summarized/copied from https://www.sandiego.gov/city-clerk/officialdocs/council-agendas-minutes-results (Select Feb 8, 2022, Click Item #333) and https://www.sandiego.gov/city-clerk/officialdocs/council-agendas-minutes-results (Select Feb 8, 2022, Click Item #333) and https://www.sandiego.gov/city-clerk/officialdocs/council-agendas-minutes-results (Select Feb 8, 2022, Click Item #333) and https://www.sandiego.gov/development-services/news-programs/programs/companion-junior-units.

Definitions:

- Accessory Dwelling Units (ADUs) commonly known as Granny Flats detached or attached structures on a residential lot; permanent housing; shall not be used for rental terms less than 31 consecutive days.
- <u>Junior Accessory Dwelling Units (JADUs)</u> dwelling unit 500 s.f. or less in size and within existing or proposed single family unit or detached garage or attached or detached ADU. May include separate or shared sanitation facilities.
- <u>Transit Priority Area (TPA)</u> "an area within one-half mile of a major transit stop that is existing or planned..." The map at https://www.sandiego.gov/sites/default/files/transit-priority-map.pdf currently shows most of Serra Mesa except for the Birdland area outside of a TPA.

Size (gross floor area):

- ADU: Minimum, 150 s.f.; Maximum, 1200 s.f.
- JADU: Minimum, 150 s.f.; Maximum, 500 s.f.

Parking for ADU and JADU: No parking spaces required (including not required for garage conversions).

Setbacks for ADU and JADU:

- If conversion of existing structure, may adhere to setback of existing structure.
- If addition to existing structure proposed, ADU adhere to the front and street-side setbacks. 0' setback for side and rear yard allowed for single story; 4' for multi-story.
- If new structure proposed, ADU adhere to front and street side yard setbacks. 0" setback for side and rear yard allowed for single story; 4' for multi-story.

Building Permitted within Single-Family Zone

- 1 Single Dwelling Unit
- 1 ADU
- 1 JADU

ADU Bonus Program: One additional ADU permitted for every ADU on premises that is set aside as affordable for period of not less than 15 years. No limit to number of bonus ADUs within a TPA; one bonus ADU outside a TPA.

Development Impact Fees: First 2 ADUs are exempt; all ADUs in excess of two greater than 750 s.f. pay proportionate or scaled DIF.

Tree: If 2 or more ADUs or JADUs constructed, 2 trees must be provided on site for every 5,000 s.f. of lot area; minimum, one tree.

Other Regulations

ADU: owner who agrees to reside in one of dwelling units for minimum of 3 years is exempt from paying Development Impact Fee.

JADU: separate exterior entry, separate independent kitchen, may have separate independent sanitation facilities, property owner required to live on-site, not be leased for term of less than 31 consecutive days, neither primary dwelling unit nor junior unit may be sold or conveyed separately and owner shall reside in either primary dwelling unit, ADU or JADU.

SB 9 requires that the City ministerially approve the subdivision of a parcel zoned for single family use into two equal parcels (not less than 1,200 s.f.). The owner is required to reside for a minimum of three years in one of the lots.

City's Implementation of SB9

- Maximum of 4 units
- Exclusions in Very High Fire Hazard Severity Zones
- 4' setbacks for multistory units
- No required parking space inside TPA; 1 parking space for 3rd and 4th unit outside of TPA
- 2 trees for every 5,000 s.f. of lot area with minimum of one tree
- ADUs and JADUS not allowed

Franklin Ridge Road Connection Update

Background: An environmental lawsuit regarding the approval of the road connection from Phyllis Place in Serra Mesa to Civita in Mission Valley was filed on November 27, 2017. A 501(c)3 nonprofit Board, composed of representatives from Civita and Serra Mesa, sued to protect public safety and the quality of life in Civita and Serra Mesa. On January 28, 2020, more than two years later, the San Diego County Superior Court ruled against the environmental lawsuit. The decision supported the City's process. An appeal was filed on May 21, 2020. On December 16, 2021 the Court of Appeal ruled against the appeal and supported the judge's ruling against the environmental lawsuit.

Issue: If this freeway connector is completed, *lives are at risk*. A 4-lane, 55-mph freeway connector will immediately allow over 23,000 cars daily increasing to over 34,000 cars a day through Serra Mesa and halfmile stretches of Via Alta and Franklin Ridge roads in Civita. This freeway connector will clog the only access road for many homes in Serra Mesa, creating a dangerous situation for emergency access and evacuation of that area. Also, the road connection creates a safety risk for the elementary school at the corner of Via Alta and Civita Blvd scheduled to open in Fall 2022.

Action: Petition for Review filed with the Supreme Court of California on January 25, 2022. Petition at http://www.serramesa.org/hot-topics/.

Free Courses Adults 55+ Can Take for Personal Enrichment

This spring, adults 55 and older can learn another creative skill for no-cost that enhances brain function and reverses the effects of age-related decline. From playing the Ukulele, watercolor painting, healthy living to preparing for retirement, San Diego College of Continuing Education's (SDCCE's) Emeritus Program offers free online and hybrid classes throughout San Diego county.

Nearly 200 free courses are specifically designed for older adults to help maintain independence, stay intellectually stimulated, socially engaged and physically fit.

Among the most popular choices are, Rediscover San Diego Art, scholars journey through virtual tours inside the studios of local modern artists and after engage in lecture-discussion. For cinema fans, the Favorite Books as Movies course explores literary techniques in addition to film adaptations. Inside the Health Education classroom, students learn how to reduce stress and anxiety through physical and mental health exercises. Traditionally offered on campus, many classes are currently offered online and partially online.

"SDCCE's Emeritus program really keeps my mind and body going especially through the COVID-19 pandemic and encourages socialization," said Joan Stevens, 82, a retired elementary school teacher from Brooklyn. She first learned about free classes at SDCCE at age 64 when she enrolled in a music appreciation class and has been a student ever since.

During the spring semester, Stevens will take opera, music appreciation, literature, play reading, history of rock and roll, brain fitness, creative writing, and art appreciation.

New this year at SDCCE is the Law & the Retiree curriculum series. "Whether retired or planning to retire, this series gives an overview of legal topics in areas of healthcare, insurance, housing, and retirement. Students can use this knowledge to better communicate with public agencies or personal representatives such as their lawyers and doctors," said SDCCE faculty Harvey Zeytuntsyan, J.D.

Mission Center Canyon A

Background

The City of San Diego has more than 3,000 miles of sewer pipelines to provide wastewater services to its businesses and residences. Some pipelines are more than 100 years old, are deteriorating, and are in need of replacement, repair and upgrades. To avoid future service disruptions, such as sewer pipeline stoppages and spills, the aging pipelines will be replaced or rehabilitated. The new pipelines will bring the existing sewer pipelines up to modern standards, accommodate community growth and reduce maintenance requirements.

Project Overview

Mission Center Canyon A project will replace the aging and deteriorating sewer pipelines in the Birdland and Serra Mesa areas of San Diego. The construction of this project will take place on City right-of-way (streets) and other paved surfaces. The project will:

- Replace 0.57 miles (3,017 feet) of existing 8-inch sewer pipelines
- Rehabilitate 0.11 miles (606 feet) of existing 8-inch sewer pipelines
- Resurface/ Slurry streets impacted by its construction activities
- Install new curb ramps that will improve mobility access for people with physical disabilities
- Use best management practices (BMPs) for erosion control, storm drain inlet protection and restoration of disturbed areas to their original condition

Project Budget

This project's construction budget is \$2.1 million.*



Native Plant Installation in Ruffin Canyon

On February 5, San Diego Canyonlands and Friends of Ruffin Canyon had a native plant installation in Shawn Canyon. Canyonlands has been working for months to clear non- native invasive plants out of the Taft Ruffin Canyon area. Volunteers came from all over the county to help. Two high school groups, one from Del Norte and one from Point Loma pitched in the dig the rocky soil and plant the plants that were purposely place by Canyonlands in 3 areas of the canyon. After planting and watering protective cones were placed around the plants to discourage rabbits from nibbling on the new natives.

Friends of Ruffin Canyon and Canyonlands will be in the Canyon again on March 5th from 9 am to 12 pm to clear more invasive non-native plants from the landscape. If you are interested in volunteering for this event, you can sign up on the San Diego Canyonlands website or show up on the 5th at the Shawn Canyon entrance. Hope to see you there.

Taft Joint Use Project Update

An article in the last Observer edition described the Taft Joint Use Project and the issue with the stage being removed from the design. There was a contradiction – in 2018 the community was assured by our former city councilmember and the Parks & Recreation Department representative that the project was fully funded. But now the department indicates that because of insufficient funding the concrete flush stage pad and curved seat wall have been removed.

The department has provided a breakdown of funding and assured us that the City isn't paying for any amenities that are specifically required by the school district. The school district is contributing 5.3 acres of land and approximately \$4.8 million; the City, \$3 million (additionally \$419,000 was spent "to complete the public input GDP and construction document phases of the project").

An email has been sent to City Councilmember Raul Campillo's office asking for a staff response to the following questions:

- Why can't a walking path be designed to go around the stage?
- How much does it cost to build a stage?
- Why wasn't the community kept informed about the changes by staff and the Mayor's office?


